 Whittington from the Council delivers M^r Speaker the following Message
 By the Council in a Assembly Novemb^r 12th 1753. — We have taken
 all possible Care to cultivate a good and amicable Correspondence with
 your House this Session and cannot but think you use us very ill in
 denying a Conference which we take to be the only Expedient to remove
 the Difficulties seeming to have created a Misunderstanding betwixt us
 and to dispatch Business. We do not pretend to direct whether you should
 Address her Majesty in Answer to S^t Thomas Laurences Complaint
 nor would such Conference with us prevent your so doing, tho' you
 should be happily convinced that it is your Interest to give a ready and
 Obedient Obedience to her Majesty's Commands. which we have so earnestly
 recommended to you and press you to Comply with. Wherefore if her most
 Sacred Majesty should conceive any displeasure (as it is to be feared she may)
 at your neglect or Contempt we hope we shall not fall under it but if
 any hardships should hereafter be put on the Country on this score you
 will be found to be those who have neglected the true Interest of it and
 invited us in such Misfortunes. This we must needs assert and
 cannot but leave it on our Journall that it may plainly appear
 whether you or we have the truest sense of duty and Regard to her
 Majesty's Honor and the Interest of the Province we in demand^(ing)
 or you in refusing to usual reasonable and necessary a Conference which
 we cannot but yet Expect from you. Sign'd Order W^laden C^o Council.
