Col<sup>o</sup> Holland and Capt Smith being called into the House and both their Petitions read  
and the House having heard what they had to say Col<sup>o</sup> Holland prayed Leave for a  
copy to make his Defence and is ordered to withdraw

And then the House resolves on Saturday Morning next to take the same into  
further Consideration and that Col<sup>o</sup> Holland and Capt. Smith be ordered then to attend  
the House.

Read the first time and by especial Order do pass. Signed by Order

Bill prohibiting the Sale of Protestant Servants to Papists and white women  
Servants working in the Ground &c Read the first time. Put to the Vote whether  
the Bill shall pass or not? Carried in the Affirmative that the Bill do pass  
Whereas it appears by the Journal of the Committee for laying the Levy last Year  
that Col<sup>o</sup> Dowry in the Right of his son Samuel Dowry was 20<sup>th</sup> Sterling  
for one Years Rent of the House. It is therefore ordered that the Treasurer pay the  
same to Samuel Dowry according to the Vote of the House and not to the Executors  
of the Said Col<sup>o</sup> Dowry. The House adjourns till to Morrow Morning Eight O'Clock

Thursday e April 11<sup>th</sup> 1706

The House met again according to Adjournment. Being called over were all present  
as Yesterday. Bill investing certain Lands in John Whittington & his Heirs  
for  
Bill restraining Papists or reputed Papists from purchasing Protestant or reputed  
Protestant Servants and for preventing Abomination committed by white Servants  
working in the Ground &c Indorsed April 10<sup>th</sup> 1706 By the House of Delegates  
(Read the first time and put to the Question whether the Bill pass or not?  
Carried in the Affirmative Signed by Order W. Taylard (P. Ho. Deb)

April 11<sup>th</sup> 1706 Read the second time and do pass. Both sent up to the Council  
of Mr William C. Iniquith and Mr Joseph Emmells for their Concurrence.  
They return and say they delivered them (Proposal)
