

Bill empowering Thomas Edmondson to sell land of Indorped By the Council in Assembly  
October 31<sup>st</sup> 1711 Read in Council and will pass M<sup>r</sup> Bladen S<sup>r</sup> Council

Bill for Naturalization of Peter Saunders and others indorped October 31<sup>st</sup> 1711 Read  
in Council the first and second Times and will pass M<sup>r</sup> Bladen S<sup>r</sup> C.

Bill investing Land in Richard Bennett Esq Indorped By the Council in Assembly Oct 31<sup>st</sup> 1711  
Read the first Time and will pass with a saving to the Lord Baltimore's Right of Excheat if any  
M<sup>r</sup> Bladen S<sup>r</sup> Council

The several Bills, except M<sup>r</sup> Bennetts Read in the House and past for ingrossing.

Bill reinvesting Land in Seward's Heirs, Read again, Put to the Question whether the  
Bill pass or not? Carried in the Affirmative, and Resolved the Bill pass

Sent up to the Council by M<sup>r</sup> Greenfield and Capt Crabb. They return and say they delivered  
the Bill — M<sup>r</sup> William Wilkinfon moved that he might have leave to go home  
upon extraordinary Occasions which was granted by the House

Bill investing Land in Richard Bennett Esq Read with the Amendments proposed by  
the Council. Put to the Question whether the Bill pass with the Amendments proposed by the  
Council, or not? Carried in the Negative

Resolved the Bill be referred for further Consideration to Morrow Morning

Colo Addison enters the House and delivers M<sup>r</sup> Speaker Bill for reinvesting Seward's Heirs  
into Land Indorped 31<sup>st</sup> October 1711 By the Council in Assembly The Lord Proprietary  
having no Agent at present to be heard to this Bill it's referred to the next Session accord-  
ing to former Order Signed of Order M<sup>r</sup> Bladen S<sup>r</sup> Council

Also Prince George's County Petition about the Ferry

The House adjourned till to Morrow Morning Nine o'Clock

Thursday 1<sup>st</sup> November 1711 The House met according to Adjournment Being  
called over were present as Yesterday except M<sup>r</sup> William Wilkinfon who had Leave to go  
Home — Read what was done Yesterday

Bill investing Land in Richard Bennett Esq. again read and committed for Amendment

Bill investing Land in Seward's Heirs again read and referred till next Session of Assembly.

Ordered the Treasurer of the Western Shore send for a Slagg and six Drum Lines for the  
publick Use and at their Cost and Risque.

The Honble Colo Tilghman enters the House and delivers M<sup>r</sup> Speaker the Journal of the Com-  
mittee of Accounts presented to by the Honble Council

M<sup>r</sup> Philips, M<sup>r</sup> Bordley, M<sup>r</sup> Hill, M<sup>r</sup> Bradford and M<sup>r</sup> Scott appointed to join with some  
Members of her Majesty's Honble Council to apportion the publick Levy —
