Lower House of Assembly of the Province of M A R Y L A N D.

(Tuesday, August 2, 1729.)

THE House met according to Adjournment. The Members were call'd over, and all present as yesterday. The Proceedings of Yesterday were read.

The Question being put, Whether the Three-Half-Pence per Hoghead should be applied to the Governour for Three Years, or One Year? Resolv'd it be for Three Years.

Order'd, That Mr. Harris, Mr. Fenings, Mr. Key, Col. Gale, and Mr. Hollyday, do prepare an Address to the Governour, in Answer to his Message sent here from the Upper House, by Mr. Edward Henry Calvert, and Eight more.

John Hall, Esq; and Two more, from the Upper House, deliver to Mr. Speaker, the Bill, Intituled, *An Act for raising a Duty of Three-Pence per Hoghead, &c.* with a further Indorsement made therein, than was when the Bill was sent here before; and the following Message, viz.

Gentlemen,
By the Upper House of Assembly, August 2, 1729.
On considering your Message of the 22d of July last, by Col. Herman, and Mr. Turbutt, relating to the Bill for raising a Duty of Three-Pence per Hoghead on Tobacco exported out of this Province, for the use therein mentioned, We observe, that you do not offer any Reasons why you cannot consent to the passing that Bill, with a longer Continuance than for One Year only: And as our preceeding Governours have had the Gratuity from the Country, at least for Three Years, and generally during the Continuance of their Government, We think ourselves obliged to shew the same, if not a greater Respect to his Excellency, our present Governour, in Regard of his near Relation to our Proprietary, and his own Merit; and therefore propose to your House the Continuance of that Bill during his Government.
