The Inconveniences which we foresee in the making an equal Distribution of the Publick and other Tobacco Dues, when collected by the Sheriss, according to the Directions of the Tobacco Law, (so that every Person interested therein, may have his just Proportion, as well in Morey as in Tobacco, and so mutatis mutandis, according to the Payments made to the Sheriss in either Specie,) appears to this House to be many and very intricate: We therefore think it worthy the Consideration of the Legislature at this Time, to consult of certain Heads or general Rules to be laid down as Directions to the several Sheriss within this Province, in the making Distribution of the Publick and other Tobacco-Dues, so that no one Person be preferred to the Prejudice of an ther; but that the meanest Planter, who hath any Claim in the Publick, may have his just Share of the Tobacco, when that is most valuable, or of the most Money, when most eligible, according to the Quality of the Payments, bond side, made to the Sheriss of each County: We therefore propose the joining some Members of your House with some of Ours, in a Conference to consider of the most proper Measures for the Accomplishment of so good an End.
