WE, His Majesty's most Dutiful and Loyal Subjects, the Representatives of the Freemen of *Maryland*, return your Honour our humble and hearty Thanks for your kind Speech at the Opening of this Session, and for recommending Loyalty, Moderation and Justice to us, in so handsome a Manner; which a Sense of our Duty, as well as your Honour's Recommendation, will (we hope) incite us to pursue.

WE will make the best Provision we can, to secure the publick Records from Accidents, and use our utmost Endeavours to acquit ourselves in the Service of our Country, as becomes Loyal Subjects, and Honest Men.

The Petition of *Christopher Gardiner*, refer'd from the Upper House, was read and rejected.

*Daniel Dulany*, Esq; brings into the House an Address to the Governour ingross'd; which being read, is approv'd; and the Speaker, by Order of the House, sign'd the same. Whereupon *John Beale*, Esq; and Capt. *Robert Gordon*, are order'd to go and acquaint the Governour, that this House hath prepared an Address to his Speech, and desirous to know if he is at Leisure to receive the same: They return, and acquaint the House with the Delivery of their Message; and that the Governour would be ready to receive the same in half an Hour. Accordingly the following Gentlemen are order'd to present the same to the Governour, viz. *Daniel Dulany*, Esq; Mr. *Key*, Mr. *Samuel Hanson*, Mr. *Magruder*, Mr. *Crabb*, *John Beale*, Esq; Col. *Fendall*, Mr. *Joshua George*, *Edmund Jennings*, Esq; and Col. *Joseph Belt*; who return and say they deliver'd the same.
