May it please your Honours,

In Answer to your Message of this Day, by *Philemon Lloyd, Esq;* this House being sensible of the Necessity of a Law to explain the Tobacco-Law; and also being satisfied with the Reasons which this House hath before given to your Honours, of the Injustice in the Exemption of the Officers Fees in the Bill now propos'd, We have thought convenient to offer to you the following Expedient, viz. To admit your Amendment, by the Omission of the Words, *and other Officers*; and to fix the Number of Plants to the Number regulated by the Tobacco-Law: And also that Tobacco Debts may be discharged in the same Manner and Proportion as the Tobacco-Law directs.
