Col. Greenfield, from the Committee appointed to prepare an Address to the Lord Proprietary, reported to Mr. Speaker, that the Gentlemen appointed by the Upper House, to join in the said Address, acquainted them, that they had not Instructions to prepare any other Address than what was mentioned in the Message of both Houses.

Order'd, That there be no Suit commenced on Mr. Ungle's Bond, as Treasurer for the Money due for defraying the Publick Charge of this Province, until the next Session of Assembly; and that Mrs. Ungle, the Administratrix of the said Mr. Ungle, lodge the Money due (being 381 l. 18 s. 10 d. Sterl.) to the Publick, in the Hands of Mr. William Hunt, Merchant, in London, before the next Session, for the Use of this Province; and that the lodging it in the Hands of the said Mr. Hunt, accordingly, shall discharge the Treasurer's Bond aforesaid; so far only, as it is chargeable with the Payment of the said Money.

The ingross'd Bill, Intituled, *An Act to ascertain the Fees of Practitioners of the Law within this Province, and to prevent Extortions, Frauds, and Abuses therein.* was read, and assented to; and sent to the Upper House, by Col. Greenfield, and Five more; who return, and say they delivered the same.

The Journal of the Committee of Accounts was read, and assented to; and sent to the Upper House, by the Gentlemen of the Committee of Accounts.

The ingross'd Bill, Intituled, *A Supplementary Act to the Act, Intituled, An Act for the Establishment of Religious Worship, in this Province, according to the Church of England, and for the Maintenance of Ministers,* was read and assented to; and sent to the Upper House, with the Paper Bill, by Mr. Hambley; who returns, and says he delivered the same.

An ingross'd Bill, Intituled, *An Act for the Relief of John Smith, a languishing Prisoner in Cecil County Goal,* was read and assented to; and sent to the Upper House, with the Paper Bill, by Mr. Johnson, and Mr. George; who return, and say they delivered the same.

Order'd, That it be an Instruction to the Members of this House, appointed to join with some Members of the Upper House, to prepare an Address to the Lord Proprietary, to observe the Substance of the several Messages passed between both Houses, in drawing and preparing the said Address; and that they signify to his Lordship, the Hardship the Province labours under by his Dissent to the Laws.
