we can, by avoiding Disputes about any particular Words of Phrases, provided we have the Benefit of the Laws of our Mother Country secured to us; without which, your Committee conceive, we cannot be fecure in any Thing, your Committee propose the following Alteration; that instead of these Words, viz. according to the Laws, Statutes, and reasonable Customs of England, agreeable to the Usage and Conflitution of this Province ; the following Words to be inferted, viza according to the reasonable Customs of England, and the Laws and Statutes thereof, as are, or shall heres after be enacted, agreeable to the Ulage or Constitution of this Province. And Submit the same to the Confideration of this House.

Sign'd per Order, William Ghifelin, Cl. Comi The House unanimously concurred with the said Report, and ordered the Committee of Laws to prepare a Bill, so ascertain the Form of Oath of Judge or Justice, conformable thereto.


