THE House met according to Adjournment. Col. *Herman*, a Representative of *Cecil County*, appear'd in the House this Day. The Petition of *St. Stephen's Parish*, in *Cecil County*, referred for Hearing on Monday.

*Philip Lee*, Esq; from the Upper House, delivered to Mr. Speaker, a Petition of several Inhabitants of the Upper Part of *Prince George's County*; which by Indorsement, is referred to this House.

The said Petition, on Reading here, referred to the Consideration of next Session of Assembly.

*Benjamin Tasker*, Esq; from the Upper House, delivered to Mr. Speaker, the Petition of *William Fell*, of *Baltimore County*, in Behalf of *Edward Fell*; which, by Indorsement was recommended here by the Upper House.

On Reading the said Petition, Mr. *Beale*, Mr. *Crabb*, and Mr. *Hem-ley*, are appointed a Committee to inspect the several Allegations therein contained.

Mr. *Dulany*, from the Committee of Laws, brought in Heads of a Bill for a Paper Currency.

THE House met according to Adjournment. A Petition of *John Baynard*, and *Elizabeth* his Wife, read, and referred for Consideration, to *Saturday* next.

*John Rousby*, Esq; from the Upper House, delivered to Mr. Speaker the following Message:

Gentlemen, By the Upper House of Assembly, 17 March, 1732. We are so desirous of omitting no Opportunity of conferring with your House, in any Matter for the Good of the Province, that we could hardly persuade ourselves from joining with your House, in the Conference, proposed by your Message of the 15th Instant; until, upon the best Consideration, we have satisfied ourselves by the Rule of Parliamentary Proceedings. Some Difference, in Point of Judgment, between the Two Houses, either on a Bill, or some other subject Matter, always precedes, or gives Occasion for a Conference; but to our mutual Satisfaction, we hope there is not any such Difference at present: Therefore, in Conformity to the Rules by which we ought to govern ourselves, as well as to avoid the very Supposition of any Difference, (since there is not any such between the Two Houses,) we think ourselves obliged to wave, at present, the Conference proposed by your Message.
