2dly, That the Colonel, Lieutenant-Colonel, Majors, and Captains, have it in their Power to deliver Arms to such Persons as they shall think proper.

3dly, That a Clause be added, to prevent Listing Servants amongst the Militia, unless upon an Emergency, to be judged of by the Field Officers.

4thly, That the Fees of the Sheriff for Execution, in Compliance of this Act, be Thirty Pounds of Tobacco, besides Imprisonment Fees; and the Clerks, Six Pounds of Tobacco, for issuing Execution; and that the same be levy'd on the Body, Goods, &c. of the Offender.

5thly, That the Colonels of the several Counties be obliged to return to his Excellency the Governor, or Commander in Chief, a List of such Arms as are lodged in the several Counties, with the Condition they are in.

6tbly, That no Officer be made liable to pay for any Arms, where the Person intrusted with them, shall lose, sell, or destroy them, and prove

insolvent, or run away, or die insolvent.

7thly, That Provision be made, that the Arms be all mark'd, and a Penalty laid upon any Person that shall sell or dispose of any Publick Arms; and likewise, upon any Person that shall purchase any, knowing the same to be such.

8thly, That Provision be made, that no Member of the Upper House

of Assembly, be obliged to serve in the Militia.

On reading the Petition of the Inhabitants of the Upper Parts of Anne-Arundel County, to both Houses of Assembly, praying, That a certain Quantity of Land might be laid out for a Town, at and about the Elk-Ridge Landing, sent down to this House, by Mr. Attorney; and conceiving, that the Indorsement made by your House thereupon, not to answer the End or Intention of the Prayer of the said Petitioners: This House hath proceeded upon an Enquiry into the Allegations of the Petitioners, and find, as is therein set forth, the Place prayed for the laying out a Town at the Elk-Ridge Landing, the most convenient and commodious of any upon Potapico River, for the Back Inhabitants of Anne-
