A Bill, intituled, *An Act to continue an Act*, intituled, *An Act for raising a Duty of Three Pence per Hogshhead, on all Tobacco exported out of this Province, for the Uses therein mentioned*, was read the first and second Time, by especial Order ; and pass'd.

Sent to the Upper House, by Mr. *Cumming*, and Three more.

A Bill, intituled, *An Act for the Relief of Anthony Parker, Patrick Reiley, and Cleborn Lomax, Prisoners in Charles County Goal*, was read the first Time, and order'd to lie on the Table.
