The humble ADDRESS of the House of DELEGATES,

My it please your Excellency,

WE his Majesty's most Dutiful and Loyal Liege Subjects, the Delegates of the Freemen of the Province of *Maryland*, in Assembly convened, beg leave to Return your Excellency our hearty Thanks for the kind Declarations in your Speech at the Opening of this Session.
