Bill, too tedious to be inserted in this Message, or in the Indorsement to be made upon passing the Bill, , we therefore desire that your House will be pleased to appoint some of your Members to join with some of the Members of our House in a Conference, to settle these particulars, which heing done, and approved of by both Houses, the Bill may be accordingly Amended and Passed into a Law; But if notwithstanding what has been said, you should think fit to persist on the Funds, and the other Parts as they now stand in this Bill, we do assure you that we are so resolved in our Loyalty and Zeal to his Majesty and every Part of his Service, that as the Passage of this Bill into a Law must forthwith answer the Royal Expectations, we shall immediately give it all imaginable Dispatch, without further confidering what the Fate or Consequence of it may or may not be hereafter, when his Majesty's Expectations shall have been fully answered by it.
