THE House met according to Adjournment. All Members present as Yesterday. The Proceedings of Yesterday were Read.

YOU *Thomas Jobson*, do Swear, that you will faithfully, diligently, and honestly Discharge the Office of Serjeant at Arms to the Lower House of Assembly; and that you shall not Disclose or Reveal the Secrets thereof. So help you God.

Capt. *Gordon* likewise acquaints Mr. Speaker, that *Thomas Sparrow*, Door-Keeper to the House, took the several Oaths to the Government required by Law, Signed the Oath of Abjuration, and Repeated and Signed the Test, and that he took the following Oath of Office, viz.

YOU *Thomas Sparrow*, do Swear, that you will faithfully, diligently and honestly Discharge the Office of Door-Keeper to the Lower House of Assembly; and that you shall not Disclose or Reveal the Secrets thereof. So help you God.
