And befor the wife Endered That the Sheriff of every respective County within this Province was shall receive any of the Dary beien before mentioned, ariling on the Bringing and Importation of Horles, Mares. or Gehings, Mailiand Mey are hereby directed, in Virtuo of their Office, to pay the fame suito the Comin moners or "I rulled for emitting Bills of Credit, effablished by Act of Assembly, before the last Day of First yearly; and so every Year during the Continuance of this Act, to be by them the faid Commissioners

applied to dueninge and repay the faid Sum of Three Thousand Pounds.

That if any Person or Persons whatsoever, shall bring or importably Land or Water, any Horfe, Ware, or Gelding, or Horfes, Mares, or Geldings, for Sale, and shall presume to fell of explication fame to bide before such Entry and Duty paid as is herein before directed, and Copy of such Entry, and Receipe for the faid Dury, fo as aforefaid had and obtained, shall forfeit for every fuch Horse, Mare, or Gelding, so sold or exposed to Sale as aforesaid, to the Right Honourable the Lord Proptietary of this Province, the Sum of Ten Pounds Current Money, one Half to the Informet who shall sue for the same, the other half to be applied to the Uses in this Act herein before mentioned

And be it titienife gnatted; That any Person or Persons within this Province, who shall purchase or buy any Horse, Mare, or Gelding, or Horses, Mates, or Geldings, imported or brought in for Sale, before the Entry and Payment of the Dury aforefaid, shall forfeit and pay to the Right Honourable the Lord Propries tary for every such Horfe, Mare, or Gelding, so by them bought before Entry and Payment of Duty as a foresaid, the Sum of Ten Pounds; one Moiety whereof to the Informer, or who shall sue for the same, the

Willer to be applied to the Ules and Purpoles in this Act before mentioned.

And be it forther Bibleed, That the Forfeitures herein before mentioned, relating to the Importation of Morfes, Mares, or Geldings, shall and may be recovered in any Court of Record within this Frowince, by Action of Debt, Bill, Plaint, or Information, wherein no Essoyn, Projection, or Wager of Law, shall be allowed,

And be it further Enaded, That if any Part of the Fines and Forfeitures beretofore arising on Ordinary Licenses, by Virtue of an Act entituled, An Act for raising and issuing Money, for maintaining bis Majesty's Porces to be raifed in rois Province, and for transporting them to the Place of Rendezvous in the West-Indies, that hath been paid to any of the Sheriffs heretofore, or now being within this Province, and which shall not be paid unto the Commissioners or Trustees for emitting Bills of Credit, established by Act of Assembly, according to the Directions of, and to the Uses and Purposes in the said Act, before the Twenty-fifth Day of Describer next enfuing; that then, and for Default of such Payment, the Attorney General of this Province that, and he is hereby directed, upon Application from the faid Commissioners or Trustees, to sue the Bonds of such Sheriffs, or the Executors of Administrators of such Sheriffs, or their Bondsmen, according to the Year wherein the Deficiency appears, or the Nature of the Case requires or will admit, for the Recovery of such Sum or Sums of Money as appears to be due for, or by Means of the Purpoles in the said Act mentioned. And the faid Committioners of Trustees are hereby required to give to the faid Attorney General for the Time being, at or before the First Day of February next enfuing, a List of such Sheriffs as have been deficient in making Payment, and the Years when the same became due respectively; as also Directions to fue fuch Sheritis Bends as kerein before directed.

And be it likewife Enacted, That if any Sheriff or Sheriffs within this Province, who shall receive any of the Fines, Forfeitures, or Duties, in this Act mentioned, and shall not; as herein before directed, pay the same to the said Commissioners or Trustees for emitting Bills of Credit, yearly, as by this Act is herein before directed; that then and in fach Case, the said Commissioners or Trustees shall, and they are hereby directed to order the Attorney General for the Time being, to put the Bonds of such Sheriffs in Suit, for the

Recovery thereof.

And be it further Enalted; That in case it shall appear to the Justices of any County-Court within this Province, that any licensed Ordinary-Keeper, by Virtue of the Act entituled, An Att for raising and issuing Money for maintaining his Mirjesty's Forces to be raised in this Province, and for transporting them to the Place of Rendezious in the West Indies, within their respective Counties, have not paid the Fines which by the said Act were payable, that then and in such Case, they the said respective Justices shall, and they are hereby authorized and directed to order the Clerk of Indicaments of their respective Counties to file and implead fuch Ordinary Keeper, and his or their Surety or Sureties, for the Recovery of fuck Fine or Fines; and fuch Clerk of the Indictments, and every of them, he and are hereby directed and authorized to prosecute the same to Effect, and upon Recovery of such Fines, or Money due, the said Justia ces of each respective County-Court are hereby directed to order the respective Sheriffs to receive the same; and when so received, to pay the same according to the Directions of the last abovementioned Act, to the Commissioners or Truffees for emitting Bills of Credit, established by Act of Assembly, and to the same Purposes and Uses as therein directed; and the said several and respective Sherists within this Province are, in Virtue of their Office, hereby ordered and directed to receive and pay the same accordingly.

And be it farther En Aced by the Authority aforefaid, That this Art, and every Matter and Clause therein, shall be and continue in full Force and Virtue, until the faid Sum of Three Thousand Pounds shall be fully replaced, paid in, and farisfied unto the faid Commissioness or Trustees for emitting Bills of Credit, established by Act of Attembly, and until the End of the next Session of Assembly which shall happen thereafter. And that in case any Sum or Sums shall happen to remain and be over and above the said Sum of Three Thousand Pounds, either received by the said Commissioners or Trustees, or other Persons, by Virtue of this Act, the faid Trutees, Sheriffs, or those in whose Hands the same shall be, shall account for the same to the next General Affembly; and such Overplus is hereby appropriated and directed to be applied towards

defraying the public Charge of this Province.

And be it Hierwife Enacted, That the faid Commissioners or Trustees for emitting Bills of Credit shall, and they are hereby directed to place to the Credit of the Account of the Province of Maryland, for Use of this Act, herein before directed to be flated, all Moneys by them to be received in Virtue of this Act, diffinguilling the Freat on which the fame shall be, by whom, and when paid. h last was
