Mr. Smith, delivers Mr. Speaker the following Report, viz.

By the Committee appointed to enquire where the Bounds of a new County, to be erected out of the upper Parts of *Dorchester* and *Queen Anne's* Counties, may most conveniently run.

YOUR Committee, by due Inspection do find, that it will be convenient to the Inhabitants of *Dorchester* and *Queen Anne's* Counties, to have the County to be erected begin at the Mouth of *Tuckaboe* Creek, and up and with the said Creek to the new Causeway, and from said Causeway with the new Road to *Dover* Road, and with *Dover* Road to the main Branch of *Choptank* River; and with said Branch to *Kent* County on *Delaware*, and with the Line of *Kent* and *Suffex* to the North-East Branch of *Nanticoke* River, and down and with the said Branch and River to the Mouth of a small Creek on which Major *James Bilings's* Mill stands, formerly known by the Name of Col. *Rider's* Mill, and with the said Creek to the Head thereof, and from thence with a freight Line to the Head of *Kakias's* Creek, and down and with the said Creek into *Choptank* River, and down the said River to the Mouth of *Tuckaboe* Creek; and all the Lands included therein to be erected into a new County.

All which is humbly submitted to the Consideration of the House.

Signed per Order, J. Ross, Cl. Up. Ho." X
