Resolved That this House will address his Excellency on the Subject thereof; and ordered that the Committee of Laws prepare and bring in an Address accordingly.

Col. Hooper and Major Hall ordered to acquaint his Excellency, that this House hath prepared an Address to him; and desires to know when and where he will be pleased to receive it: They return, and acquaint Mr. Speaker, his Excellency will be ready to receive it in half an Hour, in the Council Chamber.

Mr. Courts, with six others, sent to present the Address: They return and acquaint Mr. Speaker they have presented it.

Dr. Buchanan added to the Committee of Accounts.

On a further Consideration of Governor Clinton's Letter, the Question was put, Whether this House will give Money to the Indians, on the Subject of that Letter? Resolved in the Assirmative.
