THE House met according to Adjournment, and the Proceedings of Yesterday were read; all Members being present as yesterday, except Mr. Pemberton.

Samuel Chamberlain, Esq; from the Upper House, delivers Mr. Speaker the Bill entituled, *An Act for Limitation of Officers Fees*, Indorsed, "By the Upper House of Assembly, July 2, 1746. Read the second Time, and will not pass.

Daniel Dulany, Esq; from the Upper House, delivers Mr. Speaker the Bill entituled. *An Act to divide Prince George's County, and to erect a new one by the Name of Frederick County*, Indorsed, "By the Upper House of Assembly, July 2, 1746. Read the second Time, and will not pass.

An Ingrossed Bill entituled, *An Act empowering the Vestrymen and Churchwardens of Christ Church Parish, in Calvert County, to build a Chapel of Ease in the said Parish, and to empower the Justices of said County to levy on the taxable Inhabitants of the said Parish the Sum of eighty thousand Pounds of Tobacco, for the Uses therein mentioned; And*

An Ingrossed Bill entituled, *An Act for erecting a County School in Worcester County, and appointing Visitors for the same;*

Were read and assented to, and sent to the Upper House by Mr. Brome and Mr. Robins.

Mr. Harris delivers Mr. Speaker a Bill entituled, *A supplementary Act to the Act entituled, An Act for laying out the Town a-new commonly called Upper Marlborough Town, in Prince George's County;* which was read the first and second Time by an especial Order, passed, and sent to the Upper House by Mr. Addison and Mr. Dulany.

Mr. Speaker communicates to the House the following Message from the Governor; viz.

Gentlemen of the Lower House of Assembly,

I Will give Directions to the Attorney-General to put Mr. Ungle's Bond, as Treasurer, and Mr. Lee's Bond, as Naval Officer of ~~Potomack~~, in Suit, as you desire.

And I have given Directions to put Dr. Bradford's, Dr. Porter's, and Mr. Edward Trippe's, Sheriff's Bonds in Suit, as you desired in a former Address; to which Address I would have given you an Answer, but that I did not receive it 'til the last Day of the Session.
