Mr. Lloyd, from the Committee of Laws, delivers to Mr. Speaker, a Bill, entituled, An Act for issuing Writs of Replevin out of the County Courts of this Province; which was read the first Time, and ordered to lie on the Table.

Major Hall, from the Committee of Laws, delivers to Mr. Speaker, a Bill, entituled, An Ast continuing an Ast, entituled, An Ast for Punishment of Herfe

Stealers, and other Offenders.

A Bill, entituled, An Ast continuing an Ast of Assembly of this Province, entituled, A Supplementary Act to the Act, entituled, An Act for the more effectual Punishment of Negroes, and other Slaves; and for taking away the Benefit of Clergy from certain Offenders; and to an Att, entituled, An Att to prevent the tumultuous Meeting, and other Irregularities, of Negroes, and other Slaves; and directing the Manner of trying Slaves.

A Bill, entituled, An Act continuing an Act of Assembly of this Province, entituled, An Act for the more effectual Punishment of certain Offenders, and for

taking from them the Benefit of Clergy.

A Bill, entituled, An Ad, continuing an Ad, to prevent the Injuring of Harbours within this Province; and for Repealing the Act therein mentioned.

A Bill, entituled, An Alt continuing an Alt, entituled, An Alt to prevent cutting up Tobacco Plants, destroying Tobacco, and Tobacco Houses, and for

escertaining the Punishment of Criminals guilty of the said Offences.

And a Bill, entituled, An Act, continuing an Act, entituled, a Supplementary Act, to an Act, entituled. An Act laying an Imposition on Negroes, and several forts of Liquors imported, and also on Irish Servants, to prevent the Importing too great a Number of Irish Papists into this Province; which Bills were severally read the first Time, and ordered to lie on the Table.
