Col. Hooper delivers to M. Speaker the following Report; viz.

By the Committee of Grievances and Courts of Justice, June 7, 1751.

In Pursuance of an Order of your Honourable House, your Committee have proceeded to make the necessary Enquiries agreeable to that Order; and do find, that the Attorneys do not annex Executions to their Lists of Fees put into the Sheriffs Hands to collect, as they are under Execution by Law: That the Clerks of the Provincial, and Anne Arundel County Courts, tax their Costs on all Judgments and Actional brought agreeable to Law; making the proper Deductions fince the Inspecting Law took Place: Neither do we find their Entries or Oaths are lengthened, or more made than formerly, or any other Charge of Fees contrary to Law. But we are informed, that the Clerk of Dorchester County charges ten Pounds of Tobacco for making a Search, although the Thing searched for be not found; which we conceive is contrary to the apparent Intent of the Law.

All which is humbly submitted to the Consideration of the Honourable House.
