HE House met according to Adjournment, &c. Mr. Lizzd, from the Committee of Laws, brings in and delivers to Mr. Speaker an ingroffed Bill entituled, An Act to impower the Justices of the several County Courts, to make Provision for the late Inhabitants Nova Scotia, &c. and an ingrossed Bill entituled, An Alt for the Assessment and Payment of the Public Charge of this Province; which were severally read and affented to, and sent to the Upper House, with the Paper Bills thereof, by Mr. John Handy and Mr. John Reeder. His Excellency the Governor communicated to Mr. Speaker the following Message, viz.
