On Progression in Reading the second Time the Bill, entitled, *An Act for Reducing the Allowances of the Councillors, Deputies and Delegates, &c.* the Question was put, That the Councillors, for each Day they attend in Assembly, as Members of the Upper House, the Judges of the Court of Appeals, Delegates and Provincial Magistrates, who dwell in the City of *Annapolis*, be Reduced by the said Bill one Half less than what is allowed to those who don't reside in the said City. *Resolved in the Affirmative.*
