And it is further Resolved, That if it shall appear that General Rosbes has not paid all the Money that may be due for the Pay, Vistualling, and Cloathing of the said Men, from the Time the Money, granted for that Purpose, was expended, till the Time they were taken into his Majesty's Service, that then this Honse will make a Provision for what surther Sum may be due for the Pay, Vistualling, and Cloathing of the said Men.

Resolved, That this House will, out of the first Supplies which shall be granted for his Majesty's Service, appropriate a Sum sufficient to Reimburse General Forbes what he may have advanced, or shall advance, for the Pay and Cloathing of the Proops formerly in the Pay of this Province, and by him taken into his Majesty's Service, from the Time those Troops entered into the said Service, to the find of the present Campaign.
