

His Excellency the Governor communicated to Mr. Speaker, the following Message, viz.

GENTLEMEN of the Lower House of ASSEMBLY,

THE Inclosed will shew you what became due to the Director of the Hospital last Campaign, on Account of several of the *Maryland* Soldiers, that being wounded or taken sick, were sent thither for their Cure; I lay it before you at the Request of Mr. *Ruffel*, the Director, who having been paid by the Governments of *Virginia* and *Pennsylvania* what was due to him, on Account of the Sick that were sent to the general Hospital from the Troops which those Provinces furnished last Year for the Expedition to the Westward, flatters himself, as I also do, that you will in like Manner provide for his being immediately paid what is due to him from this Province.
