We are heartily defirous of making Provision for the Relief of the Back Inhabitants, and think a further Engagement of the Ordinary Licence Fund, should your Honours reject the Bill now before you applying that Money, one of the best Means in our Power; but as we are in a State of Uncertainty as to your Determination on the College Bill, we are under a Necessity of repeating our Yesterday's Application, that you will speedily inform us of your Resolution thereon, by which we may be enabled at once to answer the Governor's Message, and the reasonable Expectations of the distressed People who call for Assistance.
