*Samuel Chafe*, Esq; brings in, and delivers to Mr. Speaker, the following Report, viz.

By the COMMITTEE appointed by the Honourable the Lower House of Assembly, to enquire what *Laws will Expire this Session*, do find, That the following *Laws will expire at the End of this Session, unless continued.*

AN Act, entitled, An Additional and Explanatory Act to the Act, entitled, An Act empowering the Commissioners of the County Courts, to levy and raise Tobacco to defray the necessary Charges of their Counties and Parishes; made at a Session of Assembly begun and held at the City of *Annapolis*, the 10<sup>th</sup> Day of *May*, 1748.

An Act, entitled, An Act for destroying Wolves in *Frederick County*; made at a Session of Assembly begun and held at the City of *Annapolis*, the 15<sup>th</sup> Day of *May*, 1751.
