However right it might be in a general Infolvent Act, that Persons of sufficient Ability of Body to Labour, and not having Wives or Fam lies, should be obliged to a reasonable Time of Servitude, for the Benefit of their Creditors, upon their being relieved from Goal, we cannot think it would be just in the present Case, as several of the Prisoners who will be the Objects of this Bill, may probably long since have offered those Terms to their Creditors; and, having since suffered considerably by their Confinement in Goal, we hope your Honours will not desire the Hardships of Servitude should be added thereto. And, as we are greatly affected by the unhappy Circumstances of the Prisoners, and especially as the extreme cold Season of the Year is nearly approaching, we hope your Honours will not adhere to that Amendment.
