

Your Committee beg Leave further to observe, that it appears by Reports of the Committee, May 17, 1748, and September 17, 1756, they had Information from Mr. *Nicholas Hyland*, that there was then in the Hands of the Widow and Executrix of *William Rumsey*, late of *Cecil County*, as said Mr. *Hyland* was informed, near 100*l.* remaining of the 30 per Taxable delivered out to the several Counties, which the said Widow was ready to pay, when required: And it does not appear to your Committee, that the said Sum hath ever been paid into the Office: And your Committee also observe, that regular and satisfactory Accounts have not hitherto been returned from several of the Counties, of such Money: And they apprehend there may be still Balances found due from many of them, on those Monies; were proper Enquiry made therein.

All which is submitted to the Consideration of both Houses of Assembly, this 29th of November, 1765.
