It being Represented to this House, That a certain Martin Casner, an Inhabitant of Frederick County, was in Annapolis, and was capable to give Information concerning the assembling of Men in Arms at Frederick-Town. ORDERED, That he be acquainted to attend at the Bar of this House forthwith, to Answer such Questions on Oath, as shall be asked him by this House, relative to the Matter aforesaid; and the said Marcin, having attended accordingly, he made the following Deposition, viz.

HE Deposition of Martin Casner of Conococheague in Frederick County, made on the Holy Evangels of Almighty GOD, this 14th Day of December, 1765. The said Deponent saith, That some Time the Week before last, to the best of this Deponent's Remembrance, and a few Days after Col. Cresap had returned home from Annapolis, one Baptist Scott (2 Man "with whom this Deponent has had several Dealings, and whom he esteems a Man of Credit and Veracity,) came to this Deponent's Mill, and told him this Deponent, that Col. Crefap had been at his (Scott's) House, and that Col. Cresap, in Conversation about the Assembly Proceedings, had fignified that every Thing was in a fair Way of doing well, that the Journal was likely to pass, and that he expected it would pass, that the Governor seemed to be very agreeable to every Thing as was done. This Deponent further saith, that he lest home last "Tuesday Morning, and that every Thing so far as he knows was quiet in the upper Parts of " Frederick County, nor did hear otherwise than that the Public Debts were likely to be paid, " and the Journal pass, till on his Way down he heard at Jacob Young's (within about six Miles of Frederick-Trun,) that the Journal was not likely to pass; that the People in general from thence downwards, so far as this Deponent hath heard and observed, are much inflamed from an Apprehension that the Public Debts are not likely to be paid. This Deponent did not " see any People collected, armed or arming, but hath understood that there hath been Deli-" berations, whether for a Number of People to come to Annapolis.
