We therefore request your Excellency to order the Bonds of those Officers to be put in Suit for these Neglects, that those who enjoy the Profits, may see a Necessity of complying with the Du-

ties of Offices.

Was Read and Assented to, and Signed by Order of the House, by the Honourable Speaker.
