In Pursuance of the foregoing Resolution, an Admonition being prepared to be delivered by the Honourable Speaker to Mr. *Green*; and after many Debates, whether the said Admonition, as drawn up, should be received, the same was referred for further Consideration.

ORDERED, That *T. Johnson*, Esq; be added to the Committee appointed to consider and Report by what Law or Custom the Lord Proprietary of this Province receives the Fines and Forfeitures, and Amercements; as also the 12*d.* per Hoghead on all Tobaccos exported out of this Province, &c.
