By the LOWER HOUSE of ASSEMBLY, November 19, 1766.

May it please your HONOURS,

THIS House, sensibly affected with the Distressed Circumstances of the Province, and the extreme Necessity of many of the Creditors of the Public, occasioned, in great Measure, by the Want of a circulating Medium of Commerce, and, by the Non-Payment of the Public Debt, think it the most probable Mean to bring about a Passage of the Journal, that there should be a Conference between the Two Houses, which it is hoped will not only effect that good Purpose, and thereby restore Public Credit, but lay a Foundation for the Emission of a Paper Currency. We therefore propose, if your Honours think proper to signify your Approbation of the Measure, to nominate some of our Members to confer upon this Subject, with such of yours, as you shall choose to appoint.
