"And, whereas the Packing Tobacco, in bad Condition, or mixed with Trash of any Kind, for which it is refused by the Inspectors, until it is Picked over, and Re-prized, must de-preciate such Tobacco greatly, and such Negligence ought to be much discouraged, and the Buyers of fuch picked Tobacco be apprised of its inserior Quality; Be it therefore Enacted, That " it shall, and it is hereby declared to be the Duty of every Inspector, and they are hereby di-" rected and required, to certify, on the Face of every Crop Note, or Receipt, that shall here-" after be by them, or any of them, given, for any fuch picked Tobacco, that the same has been " picked." Resolved in the Assirmative.

May it please your HONOURS,

THIS House having heard, and fully considered the Allegations of John Slye, and Daniel Barnett, contained in their Petition, against the Relief of Mayberry Helmes, junt. of Baltimere County, that he had made over to, and otherwise deposited all, or most of his Estate, with his Father, in Truft, to defraud them, his Sureties, for a large Sum of Sterling Money; it appeared clearly, to the universal Satisfaction of this House, that they were only his Sureties, in a Bond for 600 l. the Consideration of a Cargo of Goods, which were divided among them, and that no Fraud whatever, has been committed, or designed by the said Mayberry Helmes, junt. or his Father, to injure the said John Slye, and Daniel Barnett, or any other of his Creditors. As he seems to this House an Object worthy of Relief, utterly unable ever to discharge his Debts, and wholly clear of all Fraud, we hope your Honours will agree to the Continuance of his Name in the Bill.

Nothing has yet occurred to this House, to deprive John Doncastle, of Charles County, of the Benefit intended him by the Bill. We therefore hope your Honours Concurrence with the Bill now returned to you, for that Purpose. Should sufficient Reasons still remain with your Honours, to induce you to refuse him his Liberty, those Reasons, when communicated to us, shall have their proper Weight.
