stable, in order to be carried to Prison; that before he could convey them thither, they made their Escape; and, altho' many Attempts have been since made to take them, they still remain at large in the Neighbourhood (being, as is supposed, countenanced and protected by some white People) and threaten to burn the Houses of such Persons, as have been, or may be active in endeavouring to secure them, which Threats have deterred many from exerting themselves. I submit it, therefore, to your Consideration, whether it would not be a very proper Step, on such an Occasion, to offer a Reward for the apprehending such audacious Rogues; and, if you approve of the Measure, I will, by Proclamation, offer such Reward as may be thought proper.
