"appointed by him or them."
In the 4th Page, instead of the Words, "to be applied, as herein before is directed," insert the following Words, viz. "to be paid to the Visitors of the Free School of that County, for

"the Use of the said School."

This Act to continue for, and during the Term of Three Years, and until the End of the next Session of Assembly, which shall happen after the Expiration of the said Three Years.
