

“ Sitting, if returned to the Provincial Court; or Three Days, in the respective County Courts,
 “ during the Sitting, if returned to any County Court, after the Return thereof, before any
 “ such Judgment shall be entered up. And, if it shall appear to the Justices of the Court, to
 “ which any such Award shall be returned, within the respective Times aforesaid, that the same
 “ was obtained by Fraud, or Mal-practice, in, or by Surprise, Impolition, or Deception of
 “ the Arbitrators, or without due Notice to the Parties, or their Attorney, or Attornies, it
 “ shall and may be lawful for the said Court, to set aside such Award, and refuse to give
 “ Judgment thereon. Signed by Order, T. WRIGHT, Cl. Lo. Ho”

Which is read the first Time, and ordered to lie on the Table.

Mr. Ringgold brings in, and delivers to Mr. Speaker, the ingrossed Address to his Excellency: Which is read, and assented to, and signed, by Order of the House, by the Honourable Speaker.

ORDERED, That Mr. Gollyborough, and Mr. Steele, do acquaint his Excellency, this House hath prepared an Address to be presented to him, and desires to know when, and where, he will be pleased to receive it. They return, and acquaint Mr. Speaker, the Governor signified he would receive it in a Quarter of an Hour, in the Conference Chamber.

ORDERED, That Mr. Worthington, and Three more, do present the Address.

The ingrossed Bill, entitled, *An Act for the building of a Parish Church, and Chapel of Ease, in St. John's Parish, in Queen-Anne's County*: Read, and assented to; and, with the Paper Bill thereof, sent to the Upper House, by Mr. Wright, and Mr. Ware.

ORDERED, That the Register of the Land-Office, do put, and keep the several Books, in his Office, in better Condition and Order, than they now are; and, that he do transcribe the General Alphabet of the Land Records, in the said Office.

The Message to the Upper House, read the second Time, approved of, and ordered to be ingrossed.

The ingrossed Bill, entitled, *An Act to empower Mary Philpot, Widow and Administratrix of Brian Philpot, &c.* Sent to the Upper House, by Mr. Wright, and Mr. Ware.
