WHEREAS sundry inhabitants of Somerset and Worcester counties, through the sinister arts of wicked and designing men, have been betrayed into dangerous and highly criminal offences against the government of this state, justly sounded on the authority of the people, in opposing the power and measures of congress, in supporting by word and deed the dominion of the British crown, and authority of parliament, obstructing the recruiting service, and holding a traiterous correspondence with the open enemies of this and other the United States, and forgetful of their duties, which they owe to themselves, as freemen, to the state, as citizens, have even threatened with impious and unnatural war, their countrymen and brethren, and for this
