Charles Godfrey's obtaining a patent for the same, the trial of which hath been hitherto postponed for the aforesaid reason of its being alleged to be Indian land; that the said Charles Godfrey, notwithstanding his having entered a caveat, and summoning the said Charles Godfrey to
appear upon the same, hath since obtained a patent for the aforesaid seventy acres of land, without his having notice thereof, or ever being heard upon the occasion, from which he is induced
to believe, that the said patent was either issued through mistake, or obtained by fraud; therefore praying the general assembly to take his case into consideration, and grant him relief: And

A petition from Robert Richardson, of Talbot county, setting forth, That a considerable time past he became security for a certain Philip Wetherell, in the sum of one hundred and eighty-five pounds sterling, payable to a certain Samuel Shoemaker, of Philadelphia; that after his so entering as security, the bond was put in suit, not only against the principal, but also against him; that before judgment was obtained, the principal died; that since his decease, a certain Thomas Place administered upon his estate, and hath paid away all the personal estate; that since the death of the said Philip Wetherell, judgment has been obtained against him for the said sum of one hundred and eighty-five pounds sterling, and interest thereon, which he has actually paid; that he can have no remedy, other than by a particular act for that purpose, and therefore praying that the house will pass an act to enable him to sell and dispose of the real estate of the said Philip Wetherell, to such amount as to reimburse him the sum he hath advanced; were severally read and ordered to lie on the table,

The house adjourns till to-morrow morning 9 o'clock.
