Mr. J. T. Chase brings in and delivers to Mr. Speaker a bill, entitled, An act to prevent de-

sertion; which was read the first time and ordered to lie on the table.

And Mr. Sheredine brings in and delivers to Mr. Speaker a bill to make the bills of credit iffued by congress, and the bills of credit emitted by acts of assembly and resolves of the late conventions, a legal tender in all cases; which was read the first time and ordered to lie on the table.

Mr. J. T. Chase brings in and delivers to Mr. Speaker the following report:

By the COMMITTEE appointed to receive all petitions and proposals for the establishment of manufactories, and to consider and devile the best ways and means of promoting trade and

commerce within this state.

YOUR committee, having taken into confideration the best means of promoting trade and commerce, are of opinion, that the repealing and declaring void all the laws of this state imposing duties on foreign, bottoms, and a duty on any articles or commodity imported into or exported out of this state (except such acts of assembly as lay duties on all negroes imported within this state), would greatly tend to encourage and advance the trade and commerce thereof. They also beg leave to suggest as their opinion, that the establishment of an insurance office, by the public, under proper regulations, would not only promote trade and commerce, but would be highly conducive to the general good.

All which is submitted to the honourable house.

## By the HOUSE of DELEGATES, March 6, 1777.

May it please your honours,

THIS house having taken into consideration that part of the resolve of congress of the fisteenth of February seventeen hundred and seventy-seven, recommending to the legislatures of New-York, New-Jersey, Pennsylvania, Delaware, Maryland, and Virginia, the appointment of commissioners to meet at York-Town in Pennsylvania, on the third Monday of this instant, for the purpose of considering of and forming a system for regulating the price of labour, of manufactures, and of internal produce, within those states, and of goods imported from foreign parts, except military stores, are of opinion, that the said recommendation ought to be complied with, and have accordingly resolved to appoint size commissioners, with a power to any three or more of them, to act in conjunction with the commissioners of the other states for the above purpose.

Should your honours concur with us in opinion, this house will immediately proceed to ballot

for the commissioners to be appointed by this state.
