province for the time being, by the late lord proprietaries, or any persons acting under their authority, together with interest thereon, at fix per cent. shall be deducted and discounted out of the faid debt due from the land-holders of this state," be struck out. The question was put, and resolved in the affirmative.

The house took into consideration the report of the committee, relative to the assessment of property in this state, and thereupon RESOLVED, That the assessment of property in the several counties may be made more equal, by afcertaining the value of the lands in the respective counties. and to fix the highest and lowest prices for the best and the worst lands, over or under which the asfessors shall not go, leaving the lands of the intermediate quality to the skill and judgment of the affessors, in whose valuation the good or ill condition of the lands, in respect to improvements or fituation, shall be observed; that valuable improvements on said lands ought to be considered independent of the rates to be hereafter specified as above. That a general rule, in respect to the value of negroes, should be adopted, also of plate, bar-iron, and pig iron: For the residue of personal property, that the same be left to the determination of the assessors, leaving a power in the commissioners to examine the returns of the assessor, and adjust them in their several counties as near an equality as possible; that all tobaccoes in the several warehouses at the time of assessment. ought to be valued by the affessors, and the affessment paid before delivery, by the inspector, except only tobaccoes belonging to the state, or where it shall appear by affidavit of the party, or some indifferent witness, that the same hath been already affessed; that proper powers ought to be vested in the commissioners of the tax, now or hereaster to be named, to call before them the several affessors, and to examine and correct their returns according to the rates hereaster to be specified, and where no returns have been made by affessors, to call on them for such returns, and to appoint new affessors where the former affessors cannot or will not act, and to use their endeavours that the affessment be in every county compleated and made as nearly equal as may be.

On motion, leave given to bring in a bill, entitled, An additional supplement to the acts for assessment of property in this state. ORDERED, That Mr. Hall, Mr. Lethrbury, Mr. Chase,
