Your committee also lay before the house for their perusal the journal of accounts, closed by resolve as of Friday the 19th instant, including an allowance to jurymen and others for services done under the late government, amounting in the whole to £. 6,501 17 9. All which is submitted to the consideration of the honourable house.
