taken such oath, they shall proceed to draw out of the several classes who have not found recruits according to the directions of this act (by ballot in such manner as the persons constituted as aforetaid shall agree to be fit and just) a man for each class, until all such classes shall be drawn?" It palled in the affirmative.
