It was proposed, that the bill under consideration be amended, by striking out the following clause: "And be it enacted, That the governor and council shall be and are hereby empowered and requested to make such regulations in each county, as may be by them thought reasonable, relative to impressing carriages, teams, and drivers, so that one part of the county may not be unequally burthened; and, during the continuance of this act, the governor and council, on any emergency, or in case of invasion, shall have full power and authority to direct carriages, horses, and drivers, or boats and hands, or other vessels, to be impressed to go out of this state, if necessary, and for a longer time than by the laws of this state is heretofore limited, not exceeding one calendar month." Upon which the question was put, and passed in the negative.
