YOUR committee, to whom the petition of Benjamin Bradford Norris, of Harford county, was referred, beg leave to report, That the facts stated in said petition appear to them to be just and true, as per vouchers to them produced; and further, that, by information given to them by Mr. Jacob Bond, a deed was executed by James Whitacre to the said Norris for the land mentioned in the petition, before he left the state, and lodged in the hands of his attorney, to be delivered to said Norris, on his making payment of two hundred pounds, which payment was not made agreeable to contract, and that the aforesaid deed is now lost or mislaid.
