of duty; and that your petitioner did, in confequence of his orders from the colonel, procure a fubstitute, to whom he paid thirty-seven pounds ten shillings; and the said substitute was accepted and proceeded to camp. Since which it is declared by your honourable house, in a supplementary act to the act, entitled, An act to regulate the militia, that all proceedings against commissioners and assessment for not serving in the militia shall be discontinued, and if the goods or chattels of any commissioner or assessment have been taken or distrained, such goods and chattels shall be restored and returned. Now your petitioner conceives himself clearly within the spirit and intention of the above recited clause, and makes no doubt but your honours will take his case into consideration, and do therein what you think just and right; and your petitioner, as in duty bound, will pray.
