RESOLVED, That the governor be requested to cause the act for naturalization to be printed and dispersed in the different parts of Great-Britain and Ireland, and to cause the same act to be translated into the German language, and printed and dispersed in the cities and towns of Germany, Switzerland, and the United States of Holland, being prepared, was sent to the senate by Mr. R. Goldsborough and Mr. Lloyd.
