That your committee find by a report in January, 1778, it appears, that the sum of £. 73 17 2 gold currency was then due from the collector of the land-tax in Queen-Anne's county, for the half year ending the 29th day of September, 1763, and that the said sum bath not yet been paid.

Your committee further take leave to report, that from the multiplicity of business, the nature of the trust, and the care and regularity of the transactions, they are of opinion, that the commissioners and clerk's annual salaries, have been very inadequate to the services they have rendered the public.

All which is submitted to the consideration of the honourable assembly, this 21st day of De-

cember, 1779.

THE committee appointed to report what provision to the civil officers of this state will de-fray their reasonable and actual expences, and also to report what compensation ought to be made to the civil officers, agreeable to the resolve of the last assembly of the 12th of August, beg leave to report, That previous to the commencement of the prefent war, the following provitions were necessary to defray the reasonable expences of the several civil officers of this state, to wit:

Governor f. 1000. Chancellor 700. Chief judge of the general court 700. Puisne judges, each 600. Judges of court of appeals, each 200. Judge of the admiralty 100. Attorney, general 100. Auditor-general 400. Treasurer 400. Clerks of the council, each 150. Treasurer 400. furer's clerk 150. Auditor's clerk 150. Clerks of the two houses, each 100. Commissioners of the loan-office, each 150. Clerk of the loan-office 100. Treasurer of the eastern shore 150. Counsellors, each 300. And considering that every necessary of life has rose to forty prices at least, imported goods far beyond that, it is but reasonable and just in the opinion of your committee, that the civil officers should receive each an addition to their salaries as will make them equivalent to what they were heretofore.

And your committee beg leave further to report, that confidering the precedent established in the case of Mr. Turner, and other circumstances, it is but reasonable and just, that the other

officers should be compensated for the services of the past year in the same proportion.

All which is submitted to the consideration of the honourable house.
