Amendments proposed. Make the word "acts," in the title, "act." Strike out from the word "mentioned," in the fifth line of the first page, to the end of the preamble, and insert as follows: 46 and it is now thought proper, that the faid bills of credit be called in, and the holders thereof paid for the same." In the sixteenth line of same page, strike out the word " laws," and infert " act."

In the seventeenth line of same page, after the word "western," strike out the words " or

eastern."

In the eighteenth line of same page, strike out "June" and insert "September."
Strike out from the word "June," in the same line and page, to the word "and" in the tenth line of the second pape, and insert as follows, " who shall lock them up in the iron chests or other fate place, which bills of credit shall be counted and burnt by a committee of both houses of assembly, to be appointed at the next session after the said first day of September next."

In the eleventh line of the second page, make the word " acts" " act." In the twelfth line of same page, Srike out the words "one of the said treasurers," and insert "the treasurer afore-said." And in the last line of the same page, strike out "June," and insert "September."

In the first line of the third page, strike out the fourth word "an" and insert "the said." In the first line from the bottom of sourth page, after the word "trustees," insert "aforesaid, or trustee herein after directed to be appointed."

After the word "exchange," in the fifth line from the bottom of the fourth page, strike out to the end of the preamble, and insert as follows. "and it is therefore reasonable that the holders

to the end of the preamble, and insert as follows, " and it is therefore reasonable that the holders of the faid bills of credit, who are compelled by this act to bring in the fame, should have it in their option either to receive bills of exchange drawn as by this act is provided, or certificates in payment for the the bills of credit."

In the second line of the fifth page, strike out "April" and insert "September."
In the ninth line of the same page, after the word "exchange," insert "or any of them."
Strike out from the word "paid," in the tenth line of the fifth page, to the word "and," in the eleventh line, and insert as follows: "the same shall be renewable, but neither the drawer or any endorser thereof shall be answerable for, or liable to pay, any damages thereon, other than the charges of protest."

Strike out from the word " bills," in the twelfth line of the same page, to the word " hereby,"

in the first line of the fixth page, and insert as follows:

46 And, Whereas the said trustees may resuse or neglect to act: Be it enasted, That one of the following persons, viz. Edmund Jennings, William Carmichael, Joshua Johnson, Jonathan Williams, or Richard Bennet Lloyd, Esquires, shall be appointed in manner herein after direcled, to act as truftee, in case of such refusal or neglect, which person, so appointed truftee for and on behalf of this state, shall be and he is."

In the fourth line of the fixth page, strike out the words " either of them are," and insert

" he is."

Between the words "the" and "trustees," in the sixth line of same page, insert the word and after the faid word " truftee" insert the word " shall," and in the seventh original line of same page, strike out the words " who shall act shall."

In the eighth line from the bottom of the fixth page, strike out the words " said trustees," and

infert " persons before named."

In the last line of the same page, strike out "trustees," and insert "persons."
In the third line from the bottom of the last page, strike out the word "acts," and insert " act."
