THE committee appointed to enquire into and report the quantity of flour, &c. procured by the commissioners appointed by the act for the immediate supply of flour and other provisions for the army, &c. beg leave to report, That it appears by the representation of the commissioners for Worcester county, that they have procured twelve thousand bushels of Indian corn in that county, the greater part whereof lies on the sea-board; that the conveyance to the different landings on the Chesapeake or Delaware bays will be very inconvenient and expensive, and that the same could be transported with expedition and at a much less expence from Sinepuxent inlet to Trenton, in the state of New-Jersey, and that your committee have therefore come to the following resolution: That the governor and the council be authorised and requested to direct the said corn to be shipped from Sinepuxent inlet for Trenton, or any other place on the river Delaware which they may think proper, or to any place his Excellency general Washington may require. Which is submitted to the consideration of the honourable house.
